## RE: Restoring Accountability, Oversight & Transparency to Our Border Enforcement Strategy

Dear Speaker Pelosi and Majority Leader Schumer:

Today, we write to you to express our support for increased accountability, oversight, and transparency at our borders and ports of entry. The current border enforcement system has failed our border communities, the vulnerable people arriving at our nation's front door, and even agents and officers themselves. As a result, our country is in desperate and urgent need of legislative reforms included in Rep. Veronica Escobar's *Homeland Security Improvement Act* (H.R.3557) and Sen. Ben Ray Lujan's *Border Accountability, Oversight, and Community Engagement Act* (S.3160).

Enacting companion legislation will establish a New Ellis Island at our southern border that lives up to the ideals of protecting the human and constitutional rights of migrants and border residents by holding agents accountable. Overhauls to immigration enforcement at the U.S. border are long overdue, and border communities have long advocated for changes, including annual reviews of ICE and CBP training protocols, body camera requirements, and creating an independent and neutral Border Oversight Panel.

It remains critical that DHS reestablish procedures that help protect the rights of immigrants and border communities alike and uphold our nation's values. Immigrants and their families are entitled to respect for their humanity and freedoms under the law. Unfortunately, the current system will continue to perpetuate inhumane treatment and repeated violations of citizen and migrant civil rights.

Federal immigration officers and agencies are accountable to the people. We must engage in more transparent accountability and enforcement policies at the border, and Congress must do more to reign in these notoriously abusive immigration agencies. Congress should hold these rogue agencies accountable for the harm and trauma they inflict. Congress can do so by exercising oversight, authorizing community engagement requirements, mandating the collection of agency misconduct data, and establishing an ICE and CBP ombudsman office.

We urge Congress to act in the best interest of our communities, economy, and the nation to pass legislation in the House—as it did in the 116th Congress—and the Senate. We look forward to working with our champions in both chambers to strengthen the bill as it moves towards passage, and we count on your leadership, support, and understanding that enacting measures to hold officers accountable for misconduct is paramount and constitutes a moral imperative.
